**Town of Skaneateles Standard Conditions  
For Public Display of Fireworks**

1. The actual point at which fireworks are to be fired shall be in accordance with the National Fire Protection Associations standards 1123, 1124 and 1126.
2. The actual point at which fireworks are to be fired shall be at least 100 feet from the nearest above ground telephone or telegraph line, tree or other overhead obstruction.
3. The audience at the display shall be restrained behind barriers as per National Fire Protection Association standards.
4. Only persons firing or in active charge of the display shall be allowed inside the audience restraint barriers.
5. Projectile type fireworks fired from land shall be so set up that the projectile will go into the air as nearly as possible in a vertical direction. Projectile type fireworks to be fired above a lake or other body of water shall be directed so that all residues will fall into such lake or body of water.
6. Any fireworks that remain unfired after the display is concluded shall be immediately stored or disposed of safely.
7. No fireworks display shall be held in wind of velocity exceeding 30 miles per hour.
8. All operators in actual charge of firing the fireworks shall be over the age of 18 years, competent and physically fit for the task. There shall be at least two such operators constantly on duty during the firing. Only those persons listed in paragraphs 6 and 7 of the application shall be permitted to handle fireworks.

9. At least two approved fire extinguishers of at least 2 ½ gallons capacity each, or equivalent fire extinguishers of other types expressly approved by the Permit Authority, shall be kept at separate points within the area of display.
